



## Product Update and Continuous Disclosure Notice – Third Link Growth Fund

This Product Update and Continuous Disclosure Notice provides important information for existing investors in the Third Link Growth Fund (Fund) including an update on the new Product Disclosure Statement (PDS).

On 18 August 2017, Bennelong Funds Management Ltd (BFML), the Responsible Entity for the Fund, issued a new PDS. The new PDS:

- includes enhanced disclosure of fees and costs as required by ASIC Regulatory Guide 97. The management fee has not been increased, however, the transactional and operational costs for the underlying investments have now been disclosed in order to comply with ASIC Regulatory Guide 97; and
- section 2 of the Additional Information to the PDS “How we invest your Money” has been amended. The new wording includes a detailed explanation of the underlying investments of the Fund. It is now specified that these investments may include different types of structures such as individually managed accounts, managed discretionary accounts, advisory accounts, listed investment companies or similar. Exposure to any one manager continues to be limited to a maximum of 25% of the overall Fund value.

If you are an existing investor in the Fund, this update will not result in any change to your unitholding.
